As we begin the new year, we are proud to share an important step forward in our mission. We have expanded our team by appointing additional Lead Representatives in several states to help establish DEWA (Direct Energy Weapons Agency) Civilian Victim Assistance Offices.

These offices are being designed to serve as an initial point of support and triage for civilians seeking help—ensuring that individuals are met with dignity, care, and informed evaluation. Victims will no longer be automatically or prematurely referred to psychiatric institutions without appropriate consideration of their reported symptoms.

Evaluations conducted through our medical framework are based on the neurological disturbances an individual may be experiencing, with a focus on careful documentation, appropriate referrals, and compassionate support. Our goal is to create a responsible, science-informed pathway that prioritizes civilian well-being while contributing to broader public understanding and accountability.

Thank you for your continued support as we work to build safer, more informed systems of care for civilians nationwide.

Main stream news has reported Pentagon studying device linked to ‘Havana syndrome’ bought in undercover operation. The device acquired by HSI produces pulsed radio waves, one of the sources said, which some officials and academics have speculated for years could be the cause of the incidents. Although the device is not entirely Russian in origin, it contains Russian components, this person added

Officials have long struggled to understand how a device powerful enough to cause the kind of damage some victims have reported could be made portable; that remains a core question, according to one of the sources briefed on the device. The device could fit in a backpack, this person said.

Safety and Protection

At this time, there is no proven or guaranteed method to fully protect homes, apartments, or office buildings from the criminal misuse of directed energy. Most standard construction materials are not designed to block energy that can penetrate walls or windows.

Some materials may help reduce or slow certain forms of energy exposure when used appropriately and with professional guidance, including:

- ◆ **Multi-Layer Shielding:** Combining lower-density materials (for scattering) with higher-density materials such as heavy-duty steel or lead (for absorption).
- ◆ **Conductive Materials:** Thick copper, aluminum, steel, and nickel silver, commonly used in shielding applications.
- ◆ **Conductive Meshes & Elastomers:** Metal-infused materials and fine wire meshes sometimes used in Faraday-style enclosures to reduce certain radio-frequency transmissions.

Many of these materials are commercially available through building supply retailers. Individuals should consult qualified professionals before attempting any installation.

Health monitoring watches can also be a supportive personal tool. When worn consistently, they may help record irregular heart activity, sudden or unprovoked body movements, and sleep pattern changes, providing time-stamped data that individuals may choose to share with licensed medical professionals. These devices are not diagnostic, but may support awareness, documentation, and informed medical discussions.

Health monitoring watches are not medical devices, do not diagnose or prevent medical conditions, and any data recorded should be reviewed and interpreted by a licensed healthcare professional.
